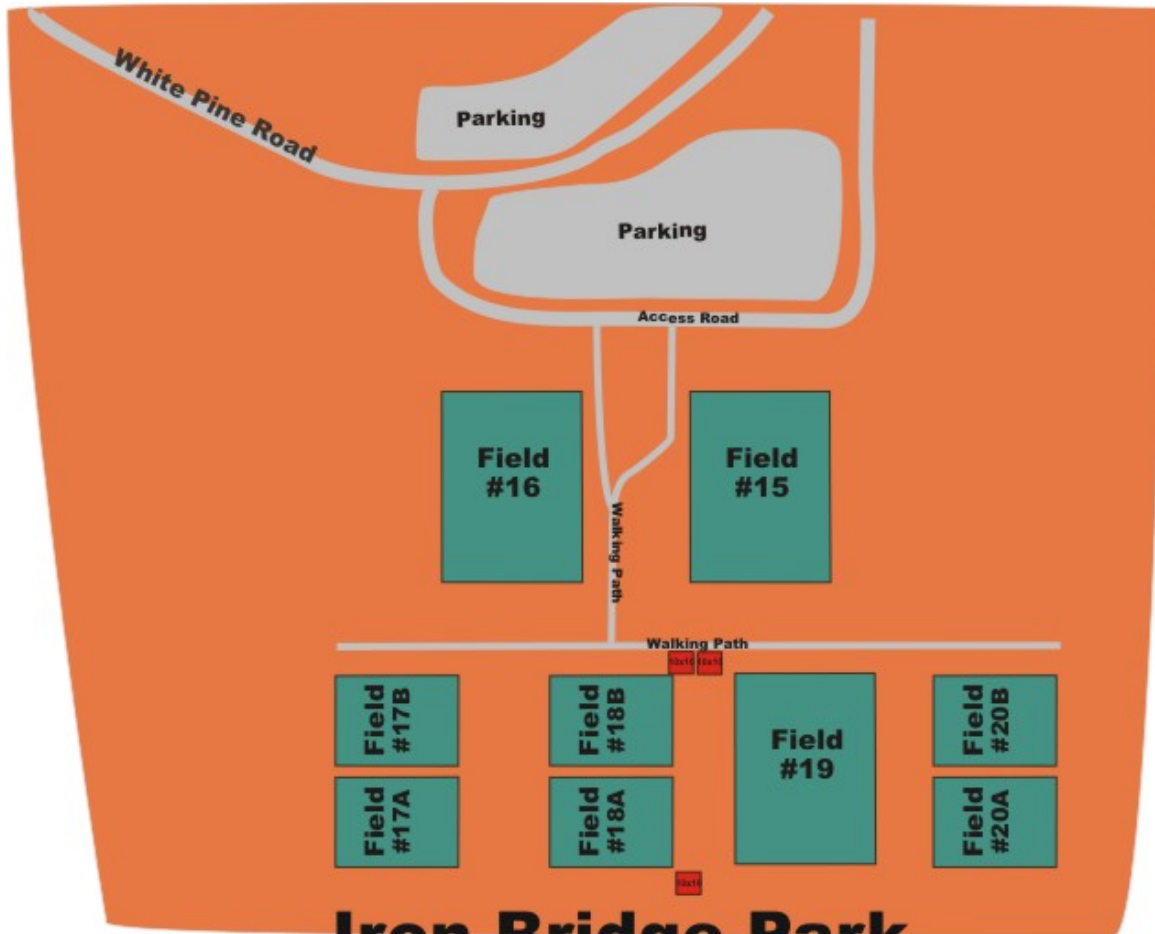
From the South: Take I-95 to Rt. 301 exit 82 (Chamberlayne Ave.). Take left on Rt. 301 North to Wilkinson Rd. (1st traffic light). Turn right onto Wilkinson Rd. and go approximately one mile (pass ball fields on your left) and turn left onto Old Sellers Way (You will see the sign for Wilder Middle School). Go one block and take the first right for parking. **PARKING:** Please Park in the parking lot at the end of Field 1 or continue around past the tennis courts and park in the Wilder Middle School lot. **DO NOT PARK** on the house-side of Old Sellers Way or on the neighborhood streets. You are allowed to park field side on Old Sellers Way, please pull in at angle to park.

From the North: Take I-295 south to the Rt. 301 South exit (Chamberlayne Ave.) and go south for about 2 miles. Take a left on Wilkinson Rd. Go approximately one mile (pass the ball fields on your left) and turn left onto Old Sellers Way (You will see the sign for Wilder Middle School). Go one block and take the first right for parking. **PARKING:** Please Park in the parking lot at the end of Field 1 or continue around past the tennis courts and park in the Wilder Middle School lot.

DO NOT PARK on the house-side of Old Sellers Way or on the neighborhood streets. You are allowed to park field side on Old Sellers Way, please pull in at angle to park



From Richmond: Travel east on I-64. Take exit 195 (Laburnum Avenue) and go south on Laburnum for 3 1/2 miles. Turn left onto Darbytown Road. The entrance to Dorey Park is 1 1/4 miles on the right. The fields are located on the right as you enter the park.

From Striker Park: Head South (left) on Pouncey Tract Road. Turn right at W Broad St/US-250. Turn left to merge onto VA-288 South. From VA-288 South (25miles) take the VA-10 W/Iron Bridge Rd exit toward Richmond. Merge onto Iron Bridge Rd/VA-10. Turn right at Whitepine Road.

From Richmond: Take Chippenham Parkway to Iron Bridge Road (Route 10). Go East on Iron Bridge Road to Whitepine Road. Chesterfield Airport is on the Right, Iron Bridge Park is on the Left. Take a Left into the Park. The fields are 0.25 miles on the Right. Look for park signs.

From Petersburg: Take Route 288 (Exit 62) North to Iron Bridge Road (Route 10). Go West on Iron Bridge Road 0.5 miles to Whitepine Road. Take a Right into Iron Bridge Park. The fields are 0.25 miles to the Right. Look for park signs.

Destination will be on the right.

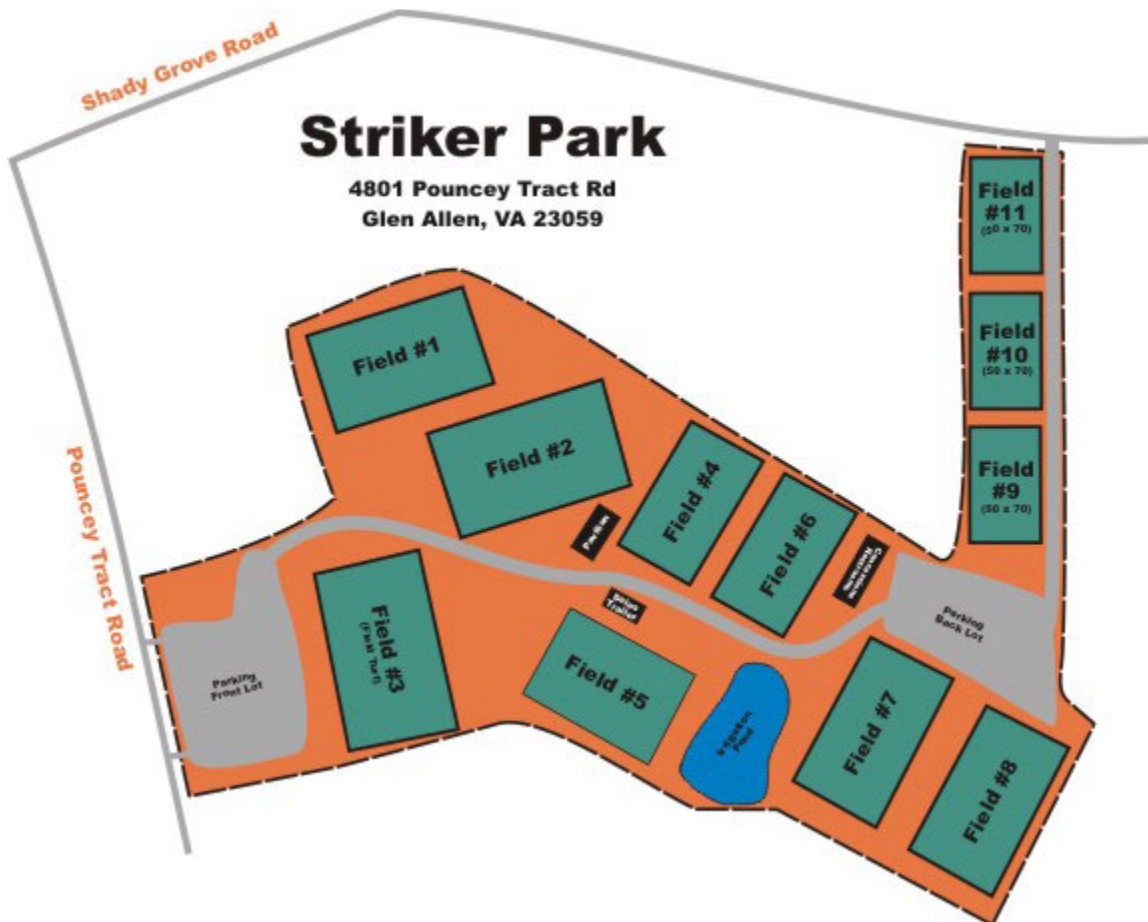
Heading South on 288: Merge onto VA-288 South. From VA-288 South (17miles) take the VA-76 S exit toward Old Hundred Rd. Merge onto VA-76 W. Turn left at Charter Colony Pkwy/Coalfield Rd/VA-754. Turn left at Genito Rd/VA-604. Make a U-turn. Destination will be on the right.

Heading North on 288: Merge onto VA-288 North. Take the State Route 604 / Courthouse Rd exit. Turn right at Courthouse Rd/State Route 604/VA-604. Turn left at Genito Rd/VA-604. Destination will be on the right

From Points East: Head West on I-64 W toward Richmond. Take exit 200 for I-295 S. toward Rocky Mt NC. Merge onto I-295 S. Take exit 25 to merge onto VA-

895 W toward Richmond. Continue onto VA-150 N/Chippenham Pkwy. Take the US-360 W/Hull St Rd ramp to Amelia. Merge onto US-360 W/Hull Street Rd. Turn right at Genito Rd/VA-604. Destination will be on the right

From Points North: Head South on I-95 S toward Exit 86B. Take exit 79 to merge onto I-195 S toward Powhite Pkwy. Continue onto VA-76 W. Turn left at Charter Colony Pkwy/Coalfield Rd/VA-754. Turn left at Genito Rd/VA-604. Make a U-turn Destination will be on the right.



From I-95: Merge onto I-64 W. Take the US-250 W exit- exit number 178A- towards SHORT PUMP. Merge onto W BROAD ST. Turn RIGHT onto POUNCEY TRACT RD/VA-271. POUNCEY TRACT RD/VA-271 becomes POUNCEY TRACT RD. Striker Park is on the Right next to Short Pump Middle School. (Approx. a mile from the Broad St. Intersection)

From I-64E: Take the US-250 W exit- exit number 178A- towards SHORT PUMP. Merge onto W BROAD ST. Turn RIGHT onto POUNCEY TRACT RD/VA-271. POUNCEY TRACT RD/VA-271 becomes POUNCEY TRACT RD. Striker Park is on the Right next to Short Pump Middle School. (Approx. _ a mile from the Broad St. Intersection)

From 295: Take the NUCKOLS RD NORTH exit- exit number 51A. Merge onto NUCKOLS RD. Turn LEFT onto TWIN HICKORY RD. Stay straight to go onto SHADY GROVE RD/VA-695. Turn LEFT onto POUNCEY TRACT RD. Striker Park is approx. 500 yards on the left.

Heading South on 288 - take the second West Creek Exit (east) which loops under Rt. 288. About an 1/8 mile take the first entrance off of West Creek Parkway. Striker entrance sign is present. See Parking Note Below

Heading North on 288 (from Chesterfield) - take the first West Creek Exit (east). About an 1/8 mile take the first entrance off of West Creek Parkway. Striker entrance sign is present. See Parking Note Below

From Patterson Avenue Route 6 (heading west) - Take the first entrance into West Creek and follow the Parkway almost to 288. Turn left into the last entrance to the Markel Complex. Striker entrance sign is present. See Parking Note Below

From Points North (Washington) - Take I-95 South to I-295 West towards Charlottesville. Follow I-295 to the end and take the I-64 West ramp. About 2 miles on I-64 West take the Rt. 288 South Exit. Heading South on 288 - take the second West Creek Exit (east) which loops under Rt. 288. About an 1/8 mile take the first entrance off of West Creek Parkway. Striker entrance sign is present. See Parking Note Below

From Points East (VA Beach) - Take I-64 East to I-295 West towards Charlottesville. Follow I-295 to the end and take the I-64 West ramp. About 2 miles on I-64 West take the Rt. 288 South Exit. Heading South on 288 - take the second West Creek Exit (east) which loops under Rt. 288. About an 1/8 mile take the first entrance off of West Creek Parkway. Striker entrance sign is present. See Parking Note Below.

Parking at West Creek: - **Upon Entering the Complex, you have the choice to go Right or Left. For fields #1 - #5 go to the Left. For fields #6 - #10 go to the Right. All Fields are accessible from either parking lot however!**

Team Check-in/Registration Requirements

- Original 2011/2012 Player Passes; either USYS State Association or US Club Soccer passes
- Two Copies of Official Roster
- Guest Players:
 - 5 Guest Players Maximum for all ages
 - Guest Players identified: Written on front or back of COPIES of Rosters
 - Player Passes for Guest Player
 - Every player guest playing from one state with another must have an approved US Youth Interstate Permission form signed by both states. Contact your State Association. *This only applies to teams who use guest players from states different from their's.*
- Individual Player Medical Release Forms including guest players
- Approved Permission to Travel forms must be received for all teams traveling from outside the state of Virginia excepted as indicated below: **Click here for Hosting Forms...**

Region 1 Policy Regarding Application To Host A Tournament

Region I has established the following policy concerning permission to travel when attending USYS sanctioned tournaments in Region I. The purpose of this policy is to make it as simple as possible for the US Youth Soccer Region I teams to travel to tournaments within Region I.

The new policy states that any USYS State Association teams within Region I that is accepted into a tournament in Region I do not need permission to travel papers. Permission to Travel is not required in friendly games within Region 1. Note is to be taken on the two (2) states that have an exception to this policy (Connecticut & New Jersey).

- No player may play for more than one team during the tournament.

Roster Sizes:

- U9 and U10 7v7 teams are limited to 14 players identified at Registration.
- U11 8v8 teams are limited to 14 players identified at Registration
- U12 8v8 teams are limited to 18 players identified at Registration
- U13 to U15 Teams are limited to 18 players identified at Registration
- U16, U17 and U18/U19 Teams can have 22 players on their rosters turned in at Registration; however teams must identify 18 players before each game with the referees. Only 18 players in each game are allowed to play.

Five guest players per team will be permitted for all age groups.

A. **Ball Size:** Size 5 U19 - U13
 Size 4 U12 – U9

B. **Game Duration:**

80 min. U17, U18, U19	Halftime - 5 min
70 min. U13, U14, U15, U16	Halftime - 5 min
60 min. U11, U12	Halftime - 5 min
50 min. U9, U10	Halftime - 5 min

C. **Substitutions:**
 Unlimited/Free substitutions with permission of referee:

1. After a goal has been made;
2. At the beginning of the second half of play or prior to the beginning of an overtime period;
3. At a goal kick by either team;
4. At a throw-in by the team in possession;
5. Injury (any number of players from both teams may be substituted whenever an injury has occurred after being beckoned onto the pitch by the Referee)

Limited substitutions may be made, with the referee's permission:

- In case of stoppage of play for an injury; or
- Cautioned player (cautioned player only)

Under no circumstances may substitutions be made (1) on corner kicks or (2) after the game has ended in a tie and FIFA penalty kicks will be required to determine a winner

All substitutes shall inform the assistant referee on their side of the field that they wish to enter the game prior to the time they are entitled to enter the game as a substitute. The assistant referee will signal the referee that substitutes wish to enter the game at the first

opportunity that the substitute is allowed to enter the game. The substitutes must wait until the referee signals that it is okay for them to enter the field.

D. **Home Team**

Team listed first is the designated Home Team and must change jerseys when the referee determines a conflict to exist.

E. **Forfeits:**

Teams not at the field ready to play with a minimum of 7 eligible players at the scheduled game time will forfeit the match at the discretion of the tournament director. Forfeited scores will be counted 3 – 0. Teams forfeiting games will not be able to advance to the playoff rounds.

F. **7/8-a-side:**

U10, U11, U12 Three referee system will be utilized if at all possible. Offsides will be called regardless.

G. **Inclement Weather:**

The Tournament Rules Committee reserves the right to make the following changes in the event of inclement weather:

- * Relocate and/or reschedule a match.
- * Change a division structure.
- * Reduce scheduled duration of a match
- * Cancel a match.

In the event of inclement weather forcing play to be halted and preventing the match from completing during the scheduled time, the score shall stand if at least one-half of the match has been completed. **The tournament director will have the final decision on field closure.**

H. **Player's Equipment:**

All players must wear shinguards. No jewelry of any kind will be allowed. Casts, splints or body braces made of a hard substance in its final form such as leather, rubber, plastic, plaster or fiberglass must be covered on all exterior surfaces with no less than ½ inch thick, high density polyurethane, or an alternate material of the same thickness and similar physical properties to protect the injury. **A medical release for the injured player signed by a licensed physician must be available at the game site. Players may not play with these casts without the approval of the Referee.**

I. **Rules for Advancement:**

Teams will be awarded points on the following basis:

Six (6) points for each Win

Three (3) points for each Tie

Zero (0) points for each Loss

One (1) point for each goal scored up to a maximum of three (3) per game.

One (1) point for each shutout

Examples:

A 0-0 tie will be scored as 4 points for each team (3 for tie, 1 for shutout)

A 4-2 game will be scored as 9 points for the winning team (6 for win, 3 for goals) and 2 points to the losing team (2 for goals).

In the event of a tie in points at the end of bracket play; the winner for advancement to Semi-Final or Finals will be determined as follows:

1. The winner in head to head competition. (If there is a 3 team tie, proceed to the next tie breaker)
2. Goal differential, max of +/-3 per game (Team wins 4-0, only gets 3 points, losing team gets -3)
3. Goals For (max 5 goals per game)
4. Goals Against (max 5 goals per game)
5. Shoot-Outs*

When the tiebreaker system is used, the criteria are followed from 1 through 4 until one team is eliminated and then the criteria starts over again at Rule #1. Rules are repeated until one team remains.

***All Shoot-Outs for 1st in Divisional play will be at 7:30am Sunday morning at a field location determined by the tournament director. Ties between 2nd and 3rd in division play leading to both teams playing consolation games will be decided by the above criteria; except for #5 Shoot-Outs. These ties will be decided by the discretion of the Tournament Director.**

J. Resolving Ties in Semi-Final and Final Match:

If the semi-final or finals match is tied at the end of regulation time, the teams will be given a five minute rest. The following will decide the match:

- Overtime will be 2 - five minute periods with substitutions allowed. Overtime will not be sudden death. Ejections will reduce the number of players on the field as normal
- If teams remain even at the end of overtime the game will be decided by the FIFA, Kicks from the Penalty Spot Procedure as outlined in the Laws of the Game; using only the players remaining on the field at the end of overtime.

K. Placement of Division:

Division of 12: 3 Groups of 4 teams. Teams will play 3 group games two on Saturday and one on Sunday. Winners of each group and one wild card (highest placing 2nd place team) will advance to the Semi-Finals. Winners of the Semi-Finals will advance to a Final.

Division of 10: 2 Groups of 3 and 1 group of 4. Group with 4 plays round robin with two games Saturday and one game Sunday; winner of the group advances to the Final. Groups of 3 will play two group games Saturday. Sunday 1st in each of the 3 team groups will play a semi-final leading to the final. The remaining teams in these groups will play consolation games 2nd vs 2nd and 3rd vs 3rd.

Division of 8: Each team will play 3 games within a 4-team group. The group winners will play for the championship.

Division of 7: All 7 teams will be placed in Group A. Teams have been randomly seeded and each team will play 2 games each on Saturday. After all games on Saturday are played all 7 teams will be seeded 1st through 7th based on the standard tournament scoring and tie-breaking procedures. The #1 team will receive a bye into the semi-finals. The remaining seeds (#2 thru #7) will play quarterfinal games with the winners advancing to the semi-finals. The losing teams will be eliminated from the tournament. Semi-Final winners advance to a Final.

Division of 6: Each team will play two games within a three-team group. The first and second place team in each group will play in a semi-final match. The third place teams will play a consolation game. The semi-final winners will play for the division championship.

Division of 5: Each team will play a four game round robin schedule. The champion will be the top finishing team by points. No Final will be played in 5 Team Divisions

Division of 4: Each team will play a three game round robin schedule. The first and second place teams will play for the division championship.

L. **Protest:**

There will be no protests. All officiating decisions are final.

M. **Sideline Behavior:**

Both teams will sit on the same side of the field. Only coaches and trainers may stay on the player's sideline. Spectators are only allowed on the opposite side of the field from the coaches and players and are limited to being in the designated area from penalty box to penalty box. No spectators are allowed behind the goal areas.

Harassment of the officials from coaches, spectators or players will not be tolerated.

N. **Send-offs:**

If a player receives a red card or two yellow cards during a match, that player will sit out the rest of that match and also their next match. Players serving Red card suspensions are allowed to sit on the bench during their teams next game but are not allowed to be in uniform. A coach or other authorized bench personnel sent off during a match must leave the field immediately upon being sent off, and must remain away from the field during the team's next match.

O. **NO** alcoholic beverages are allowed in the park or the parking lot of any of the game sites. Your team will be subject to forfeiting 1 game.

P. **Game Balls:** All game balls will be provided by tournament. Only balls provided by the tournament can be used.

Q. The tournament will be played in accordance with FIFA Laws of the Game except as modified by these rules.

R. **Tournament Cancellation:**

If the tournament is cancelled for any reason before the tournament begins and before any matches are played, teams are guaranteed a refund of an amount to be determined by the Executive Committee of the Richmond Strikers once all invoices are paid and final budgets are approved.

S. **Hotel Services:**

To insure the quality of service provided at the 2010 Capital Fall Classic, the Richmond Strikers Soccer Club has appointed Anthony Travel as our new official Hospitality Service of the tournament. All teams are mandated to book any hotel reservations through Anthony Travel to insure their place in the 2010 Capital Fall Classic. Any teams that do not comply will be at risk of forfeiting their acceptance.

Local Richmond teams or teams "commuting" to Richmond for the weekend do not have to stay in hotels but must contact either Anthony Sports or the tournament director indicating their intentions to do so.

This states "Should this event be cancelled for reasons beyond the Event Organizer's control (including weather), all outstanding reservations will be released at no charge to the participants"

T. **Team Withdrawal:**

All Entry Fees must be postmarked by September 15, 2011 to guarantee consideration. All late applications will be put on a wait list for review. Upon acceptance, the fee is non-refundable. If your team is accepted and later withdraws, the entry fee is non-refundable and sanctions will be placed against your team/club for future participation in Richmond Striker events.
